OF THE FORTY-THIRD ANNUAL SESSION OF THE SARDIS ASSOCIATION OF OLD REGULAR BAPTIST OF JESUS CHRIST

In Session Assembled With The Mount Pleasant Church, September 7, 8, 9, 1934

At the place where arrangements were made for the preaching, the services was introduced by Elder Jonah Bevins, and then the introductory sermon was delivered by Fi'der Ester Hopkins. Text: Jas. the First Chapter and 27th verse---"Pure religion and undefiled before God and the Father is this, To visit the fatherless and the widows in their affliction, and to keep himself unspotted from the world.

Then the delegation assembled at the church house and after prayer by Elder C. Cole, the Association proceeded as follows:

Called for the letters from the several churches and received the letters and seated the delegites, except the Mary Elizabeth, on motion by the clerk. The above letter was received on condition that the church exclude from their membership Ireland Stepp, and on failure to do so, the Mary Elizabeth church will automatically be cut

off from the Association. 2. The Association then organized by electing Elder Hi Maynard, Moderator, Elder Ester Hopkins, Assistant Moderator, Elder Jonah Bevins, Clerk and Brother R. L. Murphy, Assistant Clerk.

At the request of the Moderator, the Rules of Decorum were

read by the clerk.

4. Called for newly constitued churches and none responded. 5. Called for letters from sister Associations and received as fol-

erator and seated with us and aided us in council.

6. Called for transient Ministers and members of our faith and order, and received the following: Elders J. H. Brown, S. T. Wright, Ken Gillispie, James Marcum, Jeff Chafin.

7. Resolved that the Moderator make all temporary appointments.

8. Committee appointed to take care of our visiting brethren as follows: Bros. Harrison Bevins, R. L. Murphy and Jonah Bevins.

9. Committee appointed to see that the Stand be supplied with

ministers, and that peace is preserved around the stand.

10. Committee to arrange the ministry for Saturday, consisting of one member from each church, with the entire delegation of the Mount Pleasant church, who reported as follows:

1st-Elder F. H. Hopkins. 2nd-Elder L. T. Preston. 3rd--Filder Finehas Adkins. 4th--Elder Hayes Maynard.

11. Appointed Clerks to write letters to corresponding Associa-

Committee on arrangements, consisting of Elders Ester Hopkins, Acie Evins, Jonah Bevins, J. H. Brown and R. L. Murphy, with the Moderator and the corresponding Brethern and Transients invited.

13. On motion by the clerk, the Association adjourned until 9:00 o'clock Saturday Morning.

Saturday Morning, September 8, 1934 Met pursuant to adjournment, and after prayer by Elder Acie Evins, proceeded as follows

1. Called the roll and marked the absentees.

Read the Bill of Arrangements and discharged the committee on same.

3. Appointed a committee on finance, consisting of Bros. L. V. S. Curry, Harrison Bevins and Elder Willas Blackburn, who reported the contributions from each church as shown in the Statistical table.

4. Called on Treasurer to report, who reported as follows: Total on hand for 1933 \$121.41 Paid out for printing minutes \$49.00 Secretary fee 15.00 Expense of delegates to sister associations 22.32 Banking expense

Total paid out \$86.62 86.62 Balance in bank on hand \$34.79 Received from churches this year \$107.00

Total on hand for 1934 \$141.79 5. Resolved that Elder Willas Blackburn be retained as Treas-

Resolved that the clera superintend the printing of the 6. minutes and that he have 2500 copies printed and that he be allowed \$15.00 for his services for preparing manuscrpit for minutes and recording same in Association Record Book.

7. Brethern called in union meetings and Association last year made their report. Their reports received, failures excused. They all

were admonished to be more faithful this coming year.

- 12. Resolved that the Treasurer pay to the clerk of the council of Elders \$10.00 on the printing of the minutes of the above Council 13. Resolved that we print obituaries presented to the Brother
- 14. Resolved that the Treasurer pay the expense of the delegations visiting sister Associations, paying for the oil and gas.
- 15. In answer to the query from the Bethany church. The Association advises that a Deacon has no right to administer the ordinance of Baptism nor to moderate a church.
- 16. Resolved that we reprint in our minutes this year, Articles 11 and 12 from the 1926 minutes.
- 17. Resolved that we advise ministers of our Association not to marry people into adultry where either man or woman has a living wife or husband.
- Shall we receive into our fellowship men having more than one wife or women having more than one husband?

Answer, we advise the churches not to receive into their fellowship any such, except those who have put away their companions for the cause of fornications and such cases to have the Gospel or church evidence of the same.

19. Resolved that the question of the Building Committee be dropped at this time.

20. Resolved that our next Association be held with the Buck Creek church, Hemlersville, Martin County, K., to begin on Friday before the second Saturday in September, 1935, and that Elder Hi Maynard preach the introductory sermon and that Elder Jonah Bevins be his alternate.

21. Resolved that we thank the Brethern and Sisters of Mt. Pleasant church and the many friends of this community for the great kindness and hospitality shown us during this Association.

22. Resolved that the minutes be read and signed by the Moderator and Clerk. The Association then adjourned to the time and place above mentioned.

PREAMBLE TO CONSTITUTION

From a long series of expeirences, we, the churches of Jesus Christ, being regularly baptized upon our profession of faith in Jesus Christ, are convinced of the necessity of combination of churches in order to perpetuate a union and communion among us and preserve, maintain and keep the rules and orders of an association according to the following form of government.

0

Article 1—The Association shall be composed of members chosen by the different churches and duly sent to represent them in the association who shall be members whom they shall think best qualified for the purpose, producing letters from their respective churches cer-

tifying their appointment shall be entitled to seats.

Article 2—In the letters from the different churches shall be expressed their number in full fellowship, those baptized, received by letters, restored, dismissed, excommunicated and dead since their last association.

Article 3—The members thus chosen and convened shall not have any clerical power to lord it over Gods heritage or power over the churches nor shall they infringe on any of the internal rights of any church in the union.

Article 4-The Association when convened shall be governed by a regular and proper decorum.

Article 5-The association shall have a Moderator, Clerk and Treasurer who shall be chosen by the suffrage of the members pre-

Article 6—New churches may be admitted into our union that shall petition by letter and delegate, and if found upon examination to be orthodox and orderly shall be received by the association and manifested by the moderator giving the right hand of fellowship.

Article 7-Every church in the union shall be entitled to a representative in the association.

Article 8-Every query presented by any church to the association being first debated in their own church, shall be taken up by the association.

Article 9-Every motion made and seconded shall be taken up by the association except it be withdrawn by the member who made it. Article 10-The association shall endeavor to furnish the churches

with the minutes of the association.

Article 11-The churches shall send money by the delegates of each church for printing the minutes of the association.

Article 12-There shall be a record book kept wherein the proceedings of every association shall be regularly recorded by the secretary appointed for that purpose.

Article 13-The minutes of the association shall be read and corrected if need be and be signed by the Moderator and Clerk be-

fore the association arises.

Article 14-Amendments to this plan or form of government may be made at any time by a majjority of the union when they deem it necessary

Article 15—All matters coming before the association shall be

decided by the will of the majority.

Article 16-The association shall have power: (1) to provide for the general union of the churches. (2) To preserve invioably a chain of communication among the churches. (3) To give the churches all necessary advice in matters of difficulty. (4) To inquire into the cause why the churches fail at any time to represent themselves in the association. (5) To appoint any member or members by and with their consent to transact any business which they think necessary. (6) The association shall have power to withdraw from any church in this union which shall violate the rules of the association or deviate from the orthodox principles of religion. (7) To admit any orderly minister of our order to a seat with us in the association. (8) The association shall have power to adjourn themselves to any future time or place they may think most convenient to the churches of the union. (9) That no minister shall be ordained unless forwarded ed by the church and it shall require two or more ordained ministers to compose a presbytery for that purpose. -0-

ARTICLES OF FAITH

We, the churches of Jesus Christ, called Regular Baptist, are constituted on the following faith, viz:

Article 1-We believe in only one true and living God, the creator of heaven and earth and all things that are therein contained.

Article 2—We believe in Jesus Christ the eternal Son of God, who

is head and king of his church.

Article 3—We believe in the Holy Ghost the Sealer and Applier of the Redemption purchased by Christ.

Article 4-We believe in the Father, Son and Holy Ghost and

these three are one.

Article 5—We believe the Old and New Testament scriptures to be the infallible word of God and take it for our only rule of faith and practice and nothing is to be taken from or added to it.

Article 6-We believe in the free atonement of Jesus Christ, that he tasted death for every man and that salvation is to all men and women on the terms of the gospel.

Article 7-We believe that repentance and faith in the Lord Jesus Christ and regeneration are necessary previous to baptism, and that immersion is only right way of administering the ordinance.

Article 8-We believe that Christ has but one true gospel church

and that it will finally preserve through grace to glory.

Article 9—We believe in the communion of the Lord's Supper, that is, taking of the bread and wine by the Church of Jesus Christ, in commercration of the death and suffering of the Son of God until His second coming.

Jesus Christ, and ought to be observed and kept up by his church till his second coming.

Article 11-We believe that Jesus Christ is the first resurrection

from the dead and that he lives forever.

Article 12-We believe in the resurrection of the just and the un-Article 13-We believe the happiness of the saints and the punishment of the wicked are eternal.

0 BULES OF DECORUM

Article 1-The association shall be opened and closed by prayer. Article 2-A Moderator and Clerk shall be chosen by the suffrage of the members present.

Article 3-Only one member shall speak at a time and he shall arise from his seat and address the Moderator when he is about to

make a speech.

Article 4—The person thus speaking shall not be interrupted in his speech except by the Moderator, till he is done speaking and shall strictly adhere to the subject and in no wise reflect on the person who spoke before or make remarks on mishaps, failures or imperfections, but shall fairly state the case and matter as nearly as he can so as to convey his light and idea.

Article 5-No person shall rise and speak more than three times

on one subject without the consent of the association.

Article 6-No person shall abruptly break off or absent himself

from the association without liberty obtained from it.

Article 7-No member of the association shall have the liberty of laughing during the sittings nor whispering in time of public speech. Article 8-No member of this association shall address another by any other term or appellation, but the title of Brother.

Article 9-The Moderator shall not interrupt a member or prohibit him from speaking until he gives his light upon the subject ex-

cept when he breaks the rules of the decorum.

Article 10—The names of the several members of the association shall be enrolled by the clerk, and called over as often as the association requires.

Article 11—The Moderator shall be entitled to the same privilege as another member provided the chair be filled, but shall have no

vote unless the association be equally divided.

Article 12—Any member who shall willingly and knowingly break any of the rules shall be reproved by the association as they think proper.

Article 13--The delegation to be seated in this association shall

be limited to three member from each church.

Article 14-No person shall speak more than five minutes at the

same time without liberty obtained from the association.

Article 15—These Rules of Decorum shall be read by the clerk at the commencement of every association.
