- 12. The Circular Letter written by Elder B. H. Bevins was read and on motion and second, was ordered printed in our Minutes. Elder Tommy Adair was chosen to write the Circular Letter for next year.

In addition to the Circular Letter, our beloved servant Elder B. H. Bevins wrote a soul stirring letter beseeching the Association, the churches and the Brethren and Sisters to work together in love and reasoning for peace and harmony. On motion and second, it was ordered that this letter also be printed in our Minutes.

- 13. By motion and second, it was ordered that the Treasurer pay the expenses of one (1) car for visiting the Sister Associations, that is, paying for the gas and oil.
- 14. In response to a query from the Elk Fork Church and by motion, second, objection and vote of 63 to 3, it was ordered that items 14 and 15 in our 1960 Minutes be retained in our Minutes which read as follows:
- (a) "We advise our ministers of our Association

(b) "Shall we receive into our fellowship men or women having more than one wife or husband?

ANSWER: We advise the Churches not to receive into fellowship any such, except those who have put away their companions for the cause of fornication. Such cases to have Gospel or Church evidence of same."

- 15. By motion and second, it was ordered that Elders H. C. Maynard, Ester Hopkins and B. H. Bevins be retained as a Committee to approve or disapprove the book "History of the Regular Baptist Church" completed by Bro. Rufus Perrigan.
- of Faith, Constitution and Rules of Decorum in order to promote uniformity among the corresponding Old Regular BaptistAssociations, consisting of EldersEster Hopkins, B. H. Bevins, Wayne Herald, Willie White and Emmitt Case, made their report that this Committee net with like Committees from our Sister Associations at the Sulphur Springs Church, Elkhorn City, Kentucky on November 18, 1960; that uniform Articles of Faith, Rules of Decorum and Constitution were worked out, accepted unanimously by the Committees and recommended to the several Associations for approval after regular motion, second and unanimous agreement.
- (a) Aftergeneral discussion of the Committee report, Elder Wayne Herald offered a suggestion that the Articles of Faith as recommended by the Committee be amended as follows:
- (1) Article No. 1, 2, 3 and 4 remain unchanged.
- (2) Substitute for Article No. 5 the following:

"We believe that sinners are called to repentance and believe in the Gospel and regeneration of the soul and sealed with that Holy

(3) Add the following Article:

"We believe that repentance and faith in the Lord Jesus Christ and regeneration are necessary previous to Baptism and that immersion is the only right way of administering the Church Ordinance."

- (4) Article No. 6, 7, 8, 9, 10, 11, 12 and 13 remain unchanged.
- (b) After further discussion and on motion and second, it was ordered:
- (1) That we defer acceptance of the Committee's recommended Articles of Faith, Rules of Decorum and Constitution until we see how our Sister Associations receive this report;
- (2) That we print Elder Wayne Herald's suggested amendments to the Articles of Faith in our Minutes and, in addition, present these suggested amendments to our Sister Associations for their consideration;
- (3) That we retain the original Committee mentioned above;
- (4) That the Churches study the recommendations of the Committee with the idea in mind of either accepting or rejecting these recommended Articles of Faith, Rules of Decorum and Constitution at our next Association;
- (5) And that we print the Committee report in our Minutes as follows:

Elder Roy B. Akers not having been appointed by his Association, The Northern New Salem, as a delegate was seated with the committee upon regular motion and second and unanimous consent.

Several Brethren spoke briefly on the manner in which we should proceed. It was then agreed, after finding that New Salem, Northern New Salem and Sardis Associations were already similar in the documents under consideration, that we compare those of the New Salem and the Union Associations, one by one, and in a spirit of love and cooperation bring about uniformity.

The Articles of Faith were considered first. With very few minor changes of both, we approved a complete list of thirteen Articles for further approval by the several Associations at their next regular sessions by regular motion and second and unanimous agreement. A copy of our recommendations is attached hereto and made a part of these Minutes.

agreement, we adjourned until the following morning (Saturday, November 19, 1960), after prayer by Elder Banner Mann.

November 19, 1960, Saturday Morning

The committee met back at the Sulphur Springs Church House and after prayer by Elder Crockett Baker, proceeded to business.

Elder Baxter Osborne of the Northern New Salem Association being present and not having been appointed by his Association as a delegate, was seated with the committee by regular motion and second and unanimous agreement.

The Moderator by the authority vested in him then appointed a committee to give scriptural reference supporting each and every Article of Faith, consisting of Elders Elmer Church, Bruce Mullins and Baxter Osborne.

The committee then proceeded to review the Constitutions of the New Salem and Union Associations, accepting, as they deemed, the better of each, compiling a Constitution to be recommended for approval by the several Associations. This document was unanimously approved by the committee, upon regular motion and second, and a copy is attached hereto and made a part of these Minutes.

The Rules of Decorum of the New Salem and the Union Associations were compared and with very few minor changes and revisions are hereby recommended to the several Associations for approval, after regular motion and second and unanimous agreement. A copy is attached hereto and made a part of these Minutes.

Upon regular motion and second and unanimous voice, this collective committee was dissolved and are to report back to their several Associations.

After prayer by Elder Baxter Osborne, we were dismissed.

ARTICLES OF FAITH

As Adopted By The Committee

- 1. WE BELIEVE in one true and living God, the Father, Son and Holy Ghost, and these three are one.
- WE BELIEVE that the Old and New Testament Scriptures are the written, infallible word of God and the only rule of faith and practice.
- WE BELIEVE in the doctrine of election by grace, for by grace are you saved through faith.
- 4. WE BELIEVE in the doctrine of Original Sin and Man's inability to rescue himself from the fallen state he is in by nature; therefore, the Saviour is needed for the redemption.
- s. WE BELIEVE that sinners are called, converted, regenerated and sanctified by the Holy Spirit and all that are so regenerated and born again by the Spirit of God shall never fall away.
- 6. WE BELIEVE sinners are justified in the sight of God only by the imputed righteousness of Jesus Christ.
- 7. WE BELIEVE that BAPTISM, the LORD'S SUPPER and FEET WASHING are Ordinances of the Church of Jesus Christ and that true believers are the only proper subjects of these ordinances and we believe the only true mode of baptism is by immersion.

righteous and the punishment of the wicked will be eternal.

- 9. WE BELIEVE that Jesus Christ is the head of the Church and the government thereof is upon His shoulders.
- 10. WE BELIEVE no minister has the right to administer the ordinances of the Gospel except such as are regularly called and come under the imposition of hands by a presbytery of the Church.
- II. WE BELIEVE that the Church of Jesus Christ of Regular Baptist is a congregation of faithful believers in Christ who have obtained fellowship with the Lord and have agreed to keep up a Godly discipline.
- 12. WE BELIEVE every doctrine that goes to encourage or indulge people in their sins or cause them to settle down on anything short of saving faith in Christ for Salvation is erroneous and such doctrine shall be rejected by us.
- 13. None of the above articles shall be construed as to hold with particular election and reprobation so as to make God partial, directly or indirectly, nor shall any of these articles be altered without legal notice and free consent.

CONSTITUTION

As Adopted By The Committee

From a long series of experiences, we, the Churches of Jesus Christ, being legally baptized upon a profession of our faith in Christ and convicted of the necessity of a combination of Churches in order to have a union and communion among us and preserve, perpetuate and maintain a correspondence with each other in our union, we therefore, propose to keep the order and rules of an

- 1. The Association shall be called th
- 2. The Association shall be composed of members chosen by the different Churches in our union and sent to represent them in the Association and upon their producing letters from their respective Churches certifying their appointment, they shall be entitled to a seat.
- 3. In the letters shall be expressed their number in fellowship, those baptized, received by letter, dismissed, excluded and deceased since our last Association.
- 4. The members thus chosen and convened shall have no power to lord anything over God's heritage, nor shall they have any clerical power over the Churches, nor shall they infringe on any of the internal rights of any Church in the union.
- 5. The Association, when convened, shall be governed by a regular and proper decorum.
- 6. The Association shall have a Moderator, Assistant Moderator, Clerk and Assistant Clerk, who are to be chosen by the sufferage of the members present.
- 7. New Churches may be admitted to this union, which shall petition by letter and delegates, and if found, upon examination, to be orthodox and orderly, shall be received by the Association and manifested by the Moderator giving the right hand of fellowship.
- 8. Every Church in the union shall be entitled to representation in the Association.
- 9. Every query presented by the Churches to the Association, being first debated in their own Churches,

- 10. Every motion made and seconded shall be considered by the Association except it be withdrawn by the party who made it.
- 11. The Association shall endeavor to furnish the Churches with Minutes of the Association.
- Association fund for defraying expenses of the same. We think it the duty of each Church in the union to contribute such sums as they think proper and send it by their delegates to the Association, and such sums to be deposited in the hands of the Treasurer chosen by the Association, who shall be accountable for the money paid him by the Association, and paid out as the Association may direct.
- 13. There shall be an Association book kept where-in the proceedings of every Association shall be recorded by the Secretary appointed by the Association, who shall receive a compensation for his services.
- 14. Amendments to this plan or form of government may be made by a majority of the union, if deemed necessary.
- 15. All matters coming before the Association shall be decided by will of a majority of the delegates present. (This item does not apply to the government of Churches.)
- 16. The Association shall have the power to provide for the general union of the Churches and to preserve a chain of communion among the same; give the Churches all necessary advice in matters of Church difficulty; inquire into the cause why any Church shall fail to be represented at any time in the Association; appropriate the money received to any purpose it may think proper; appoint any members, by their consent, to transact any business it may think necessary; withdraw from any Church in the union which may violate any of the rules of the Association or deviate from the orthodox principles of religion; admit any orderly minister of our faith and order to a seat in the Association; and adjourn to any future time and place it deem convenient.

As Adopted By The Committee

- The Association shall be opened and closed by prayer.
- A Moderator, Assistant Moderator, Clerk and Assistant Clerk shall be chosen by the delegates present.
- 3. Only one member shall speak at a time, who shall arise from his seat and obtain consent from the Moderator when he is about to make his speech.
- 4. The person thus speaking shall not be interrupted in his speech by anyone except the Moderator until he is done speaking.
- 5. He shall strictly adhere to the subject and in no wise reflect on the person who has spoken so as to make remarks on his slips or imperfections, but shall fairly state the cause as nearly as he can so as to convey his ideas.
- 6. No person shall abruptly absent himself from the Association without leave of the same.
- 7. No person shall rise to speak more than three times on any one subject without permission from the Association.
- 8. No member of the Association shall have the liberty to laugh during the sitting of same, nor whisper in time of public speech.
- 9. No member shall address another in any other form or term than that of "brother" or "sister".
- 10. The Moderator shall not interrupt or prohibit any member from speaking until he gives his view on any subject, unless he violates the Rules of Decorum.

- 12. The Moderator shall be entitled to the same privilege of speech as any other member, provided the chair be filled, but he shall have no vote, unless the Association be equally divided, in which event he shall give the deciding vote.
- 13. Any member who shall willingly and knowingly violate any of the decorum shall be reproved by the Association as they think proper.





T

THE SARDIS ASSOCIATION

From a long series of experiences, we, the OLD REGULAR BAPTIST CHURCH OF JESUS CHRIST, being baptized upon a profession of faith in Christ are convinced of the necessity of a combination of Churches in order to perpeturate a union and communion among us and keep the order and rules of an Association according to the following plan of government.

- 1. The Association shall be composed of members chosen by the different Churches in our union and sent to represent them in the Association and upon their producing letters from their respective Churches certifying their appointment, they shall be entitled to a seat.
- 2. In the letters shall be expressed their number in fellowship, those baptized, received by letter, dismissed, excluded and deceased since our last Association.
- 3. The members thus chosen and convened shall have no power to lord anything over God's heritage, nor shall they have any clerical power over the Churches, nor shall they infringe on any of the internal rights of any Church in the union.
- 4. The Association, when convened, shall be ruled by a regular and proper decorum.

- 6. New Churches may be admitted into this union, who shall petition by letter and delegates, and if found, upon examination, to be orthodox and orderly shall be received; and every Church in the union shall be entitled to a representative in the Association.
- 7. Every query presented by the Churches to the Association, being first debated in their own Churches, shall be taken up by the Association.
- 8. Every motion made and seconded shall come under the consideration of the Association except when withdrawn by the one who made it.
- 9. The Association shall endeavor to furnish the Churches with Minutes of the Association.
- Association fund for defraying expenses of the same. We think it the duty of each Church in the union to contribute such sums as they think proper and send it by their delegates to the Association, and such sums to be deposited in the hands of the Treasurer chosen by the money paid him by the Association, and paid out according to the Association.
- 11. There shall be an Association book kept wherein the preceedings of every Association shall
 be recorded by a Secretary appointed by the
 Association, who shall receive a compensation for his services.
- 12. The Minutes of the Association shall be read and corrected, if need be, and signed by the Moderator and Clerk before the Association rises unless the same is dispensed with.

ARTICLES OF FAITH

- We believe in only one true and living God, the Father, the Son, and Holy Ghost, and these three are one, equal in power, essence and glory.
- We believe the Scriptures of the Old and New Testaments are the written words of God and the only rules of faith and practices.

- 4. We believe in the doctrine of original sin, and of man's inability to recover himself from the fallen state he is in by nature, therefore the Saviour is needed for our redemption.
- We believe that sinners are called to repentance and believe in the Gospel and regeneration of the soul and sealed with the Holy Spirit of promise, and none such shall fall away and be lost.
- 6. We believe that sinners are justified in the sight of God only by the imputed righteousness of JESUS CHRIST.
- 7. We believe that baptism is the ordinance of God's church on earth and the mode of IM-MERSION back formost soas to cover all over.
- 8. We believe that the Lord's Supper is the command of the Saviour and that by the use of bread and wine, and feet-washing should be kept up until His second coming by His believers.
- 9. We believe in the resurrection of the dead, both of the just and unjust, and that the joys of the righteous and the punishment of the wicked shall be eternal.
- 10. We believe that no minister has the right to administer the ordinances and commands of the Gospel except such as regularly ordained and baptized, and that by immersion by a legal administrator of the Gospel comes under the hands of a regularly chosen presbytery of the Church.
- 11. We believe it to be the duty of all church members to contribute for defraying all reasonable expenses of the Church, never forgetting the poor according to their several abilities.

- The Association shall be opened and closed by prayer.
- A Moderator and Clerk shall be chosen by the members present.
- 3. Only one member shall speak at a time, who shall arise from his seat and obtain consent from the Moderator when he is about to make his speech.
- 4. The person thus speaking shall not be interrupted in his speech by anyone except the Moderator until he is through.

so as to make remarks on his slips or imperfections, but shall fairly state the cause as nearly as he can so as to convey his ideas.

- 6. No person shall abruptly absent himself from the Association without leave of the Association.
- 7. No person shall speak more than three times on any subject without leave of the Association.
- 8. No person shall have the liberty of laughing during the sitting of the same nor whisper in time of public speech.
- 9. No member of the Association shall address another in any other term of appelation than that of "Brother".
- 10. The Moderator shall not interrupt or prohibit any member from speaking until he gives his light on any subject unless he violates the rules of the decorum.
- 11. The names of the members of the Association shall be enrolled by the Clerk and called as often as the Association requires.
- 12. The Moderator shall have the same right of speech as any other member provided the chair be filled. And he shall have no right to vote unless the Association be equally divided; then he may give the deciding vote.
- 13. Any member who shall willing and knowingly violate any of the decorum shall be reproved by the Association as they think proper.
